In producing herewith one accused person named Gautam Bakshi(52) s/o- Nonigopal Bakshi of Samarnagar, near old Kalimandir, W/No.46, PS. Pradhan Nagar, Dist- Darjeeling under arrest along with following articles under proper seizure:

Twelve (12) bottles of Himalayan Gold 60 up country spirit each contain 600 ml, each MRP Rs.120, Bottled by Himalayan endeavour Pvt. Ltd, Siliguri, West Bengal (Total 7lt.200ml),

I, SI Abhishek Theengh of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Gautam Bakshi(52) s/o- Nonigopal Bakshi of Samarnagar, near old Kalimandir, W/No.46, PS. Pradhan Nagar, Dist-Darjeeling to the effect that today on 30.12.2022 at 18.35 hrs received a source information that one person is selling liquor in his shop situated at Samarnagar, near Sadhu more, under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to you and as per your kind direction I along with CV/992 Jagadish Biswas, CV 242 Rakesh Mangar all of Pradhan Nagar PS had been to Samarnagar, near Sadhu more under Pradhan Nagar Police Station to verify the veracity of the information. This refers to Pradhan Nagar P.S. GDE No.1790, Dt. 30.12.22. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his shop.

Subsequently, I along with my force cordoned the shop and was able to detain the above noted person. Thereafter on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Gautam Bakshi (52) s/o- Nonigopal Bakshi Of Samar Nagar, near old Kalimondir, Ward No.46,Ps. Pradhannagar, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19:15 hrs to 19.45 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Gautam Bakshi(52) s/o- Nonigopal Bakshi of Samarnagar, near old Kalimandir, W/No.46, PS. Pradhan Nagar, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
