With due respect and humble submission, in producing herewith one accused person namely Viswanath Mahato (24) S/O Sri Ram Nihora Mahato of Dagapur, near Lokenath mandir, P.S. Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) 20(Twenty) bottles of KINGFISHER STRONG each bottle containing 650 ML Brewed and Bottled by United Breweries Ltd.

I PSI Bandhan Roy of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted accused male person to the effect that today on 30.12.22 in course K-31 mobile van duty at PS area with force C/923 Uttam Das, CV/372 Suman Kr. Saha vide PDN PS GDE No. 1776 dtd. 30.12.22 at 21.00 hrs, I received an information that the one person namely Viswanath Mahato is storing and selling liquor illegally in his Hotel at Dagapur near Lokenath Mandir, Styles as "Shib Hotel" under Pradhan Nagar PS. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search his shop recovered above noted articles, On demand apprehended person failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 21.25 hrs to 21.45 hrs and I arrested him and inform him ground of arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested accused person namely Viswanath Mahato (24) S/O Sri Ram Nihora Mahato of Dagapur, near Lokenath mandir, P.S-Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
