

I Aditya Kumar Gupta, S/o- Suresh Prashad Gupta propitier of A. F. T. (AAROH FRIUIT TRADERS), Fruits and Vegetable Commission Agent S. P- 30, Regulated Market, Mallaguri, Store Number - 4175, 4174, 4429, 4416, 4214, 4430, 4429, 4213, 4216 of Hindustan cold store, P.S.- Pradhan nagar, Siliguri, Dist-Darjeeling, would like to inform you that I am running a business of Fruits and vegetable Commission Agent and used to store various types of Fruits at Hindustan cold Store, opposite Pradhan nagar P.S at Mallaguri regulated market and as per demand of customer I used to bring/brought the cartoon of Fruits from Hindustan cold store by issuing slip in my Pad Trademark A. F. T. containing number of cartoon, store no of Hindusthan cold store where my Fruits are kept in different store number of Hindustan cold store in this course of business on 2.01.23, I have issued a slip on my pad A. F. T. Trademark for being the Fruits from cold store and when the riksaw van puller reached at cold store with my slip on my pad than the maneger of said cold store stated to that riksaw van puller Jay Jay Ram of Regulated market, Mallaguri that there is no stock of fruits cartoons in any store of A. F. T. Trademark and also stated that 20 to 30 minute

ago on 2.01.23 at about 9:00 A.M. another person namely Santosh Yadav, s/o - Sanichan Yadav of Mallagui Regulated Market had by submitting a slip on pad of A.F.T. Trademark had loaded the 13 cartoon of Apple by using fake and fake slip used it as genuine inspite of reason that I have never issue any slip to Santosh Yadav there after I along with member of market committee when to said Santosh Yadav then he stated to us that he along with Tinku Yadav, s/o - Awadesh Yadav @ Awadesh Singh and Awadesh Yadav @ Awadesh Singh father of Tinku Yadav are using the forge, fabricated fake pad in the name of A.F.T. Trademark as genuine without the knowledge of proprier of A.F.T. Trademark and since long they have brought and loaded fruits of A.F.T. Trademark of value more than Rs. 6,00,000/- (Rupees Six Lakh) by using fake, fabricated, Forged slip on A.F.T. Trade mark as they have used it as genuine for releasing of fruits from Hindustan Cold store for their illegal gain and when we started to match the stock in Hindustan cold store then I came to know that they have by using forged fake slip since 5.12.22 to 2.1.23 withdraw/Receive in Fraudulent manner more than value Rs. 6,00,000/- (Rupees Six Lakh) fruits from Hindustan cold store which causes loss of Rs. 6,00,000/- (Rupees Six Lakh) since 5.12.22 to 2.1.23 and committed cheating, fraud to procure fruits from cold store and in presence

of various members of Regulated Market (i) Santosh Yadav
(ii) Tinku Yadav (iii) Awadesh Yadav @ Awadesh Singh confessed
their guilt and requested not to lodge the complain in Police
station and one of c.c.T.V. footage is available in Hindustan
cold store and acceptance of guilt by Santosh Yadav is also
Recorded in Mobile.

So, I therefore requesting you to kindly inves-
tigate into the matter and do the needful for proper
Justice
