Respected Sir,

I, Neha Kumari Kamat, wife of Rabi Kumar Kamti, R/o. Masjid Para (Shanti Nagar), P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, would like to state that today i.e. on 01-01-2023 at about 12.30 AM (at night) when my husband was returning home with my sister-in-law from my neighbours house suddenly he saw that some local boys of Masjid Para area namely **Suresh Sahani & Subodh Sahani**, both S/o. Late Jogender Sahani, **Bishal Sahani & Akash Sahani**, both sons of Sri Suresh Sahani, **Nitin Khati**, S/o. Santosh Khati, **Fardeen Ali**, S/o. Tahir Ali, **Bishal Raghaban & Sohel**, S/o. Unknown, All residence of Masjid Para, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, INDIA, who were fully drunk was having hot altercation with my uncle. My husband went near them and tried to make them understand but they caught my husband and started physically abusing him. They physically assaulted my husband by catching his collar with hits and blow. They also snatched one golden chain from his neck. At that moment my husband anyhow managed to get rid of their hands and ran from there and returned home. They followed my husband and came to our house. After reaching our house they assaulted me and my tenant who came to save me. They were shouting like hooligans. They were in drunken condition and they attacked me with bad intention. They caught hold of me and tried to do something bad with me. They also snatched my golden mangalsutra. Due to their assault I sustained injuries in my head, my husband sustained injuries in his hand, back & knees and my tenant sustained minor bodily injuries. All of them were carrying iron rods with an

intention to kill my husband & do something wrong with me. They kicked the doors of our house with an intention to break the same. Due to their hooliganism it has become impossible to live in our own house. I and my family members are in fear due to their acts. When the local peoples came out all of them ran from our house. Finding no other option I came before you. If they are not restricted then they might create a big problem in future.

It is requested before you in folded hand to kindly take strict necessary action against **Suresh Sahani, Bishal Sahani, Akash Sahani, Subodh Sahani, Nitin Khati, Fardeen Ali, Bishal Raghban & Sohel** so they can be punished.
