I SI Srimanta Chatterjee S/o Lt Debi Prasad Chatterjee of Bhaktinagar Police Station, under Siliguri Police Commissionerate after producing one arrested accused person namely Rakesh Sha-25yrs s/o Ashok Sha of Salugara Limbu busty, PS Bhaktinagar Dist Jalpaiguri along with seizure articles (1) 14 (Fourteen) Vials LUPIGESIC INJECTION composition with Buprenorphine hydrochloride-1P equivalent to Buprenorphine 0.3Mg each vial containing 02 ML (2) 14 (Fourteen) Vials of PHENERGAN INJECTION which composition with hydrochloride-1P Vials of DIAZEPAM each vial containing 02 ML (3) 14 (Fourteen) INJECTION composition with Diazepam 1P 5 mg, each vial containing 02 ML (4) 22 (Twenty) bottles of BERRYCOF Chlorpheniramine Maleate & Codeine phosphate cough syrup which composition Chlorpheniramine Maleate 1P 4 MG Codeine phosphate 1P 10 MG each bottle containing 100 ML (5) One Black & Red colour YAMAHA scooty having Registration No-WB74BK/3321 do hereby lodged written complaint to the effect that on 03.01.23 at 21.05 hrs received reliable source information that one person was standing with a Black & Red colour scooty with huge Prohibited cough syrup and injections in the dickey of his scooty at P.C Mittal bus stand under Bhaktinagar PS to deliver the same to someone. It is reasonably believe that the person possessing the cough syrup and Injections may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 139 dated 03.01.23 and informed superiors about the plan of action. Thereafter myself along with SI Sajal Roy, ASI Dipak Karmakar, C/915 C.P.Chhetri C/1430 Dilip Barman, CVF/935 Bipllab Roy, CVF/014 Labonomoy Barman taking blank paper, wax, metal seal and knife and other investigation kits left for P.C Mittal Bus stand to work out the information vide Bhaktinagar PS GDE No-140 dated 03.01.23 & MCC No-23/23 dated 03.01.23.

At 21.25 hours I along with officer and force reached at P.C Mittal bus stand in front of Ganga Jumana Udyog and contacted the source who show us the that person from a certain distance, I briefed all Officers and force to cordon the persons as tactful as possible in order to thwart his escape from the scene. Meanwhile I called two independent witnesses namely 1) Vikash Thakur-36yrs s/o Eliladhar Thakur of Iskcon road, Bankimnagar, PS Bhaktinagar Dist Jalpaiguri and (2) Sumit Ghosg -28yrs s/o Alok Ghosh of Haiderpara Gourangapally, PS Bhaktinagar Dist Jalpaiguri after apprising them about the information received requested them in written to remain present with us during search and seizure and also called one Videographer namely Subho Roy S/O Samir Roy of Dasarathpally, PS Bhaktinagar Dist Jalpaiguri with a request to record the whole process. We rounded him up and questioned about his name and address when he disclosed his identity as above. On interrogation about the drugs, initially did not

disclose anything about this. On further interrogation he disclosed that he procured the illegal cough syrup and injections and kept in his dickey of his scooty which deliver the same to another person. Then I detained him and gave an option in writing whether he is willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that he is willing to be searched in presence of Executive Magistrate. Then I informed Sri Ashish P. Subba, Assistant Commissioner of Police, (West Zone) SPC as Special Executive Magistrate to come at P.C Mittal Bus stand, requested him to presence during search and seizure of the cough syrup and injections.

At 21.50 hrs Sri Ashish P. Subba, Assistant Commissioner of Police, (West Zone) SPC arrived at spot. Thereafter as shown by the alleged person namely Rakesh Sha I opened the dickey of the scooty of having Registration No-WB74BK/3321 and found illegal cough syrup and injections inside. I asked the accused person above named to produce document if any in support of possessing such a huge quantity of cough syrup and injections with him but he failed to produce any document. I seized the following articles under proper seizure list in presence of witness under direct supervision of Sri Ashish P. Subba, Assistant Commissioner of Police, (West Zone) SPC as Special Executive Magistrate under proper labeling.

NATURE OF ARTICLES SEIZED

- (1) 14 (Fourteen) Vials LUPIGESIC INJECTION composition with Buprenorphine hydrochloride-1P equivalent to Buprenorphine 0.3Mg each vial containing 02 ML (Total-28ML) marked as Exhibit-A

Under the above circumstances it is evident that the accused person above named procured has committing offence under NDPS act. On interrogation accused person confessed his guilt and stated that he was doing such kind of business illegally with any valid documents/License since long for his wrongful gain. It is crystal clear that the accused person is peddling prescription drugs

meant for the sick people to cater to the need of drugs abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. I arrested him u/s 41 Cr.P.C. after explaining him about the ground of arrest issuing proper meme of arrest. Arrested explaining him about the ground of articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely Rakesh Sha-25yrs s/o Ashok Sha of Salugara Limbu busty, PS Bhaktinagar Dist Jalpaiguri also arrange for its investigation.
