Respected Sir,

I, **SHANKARI SAHA**, W/O Nishit Saha, presently resident of Sitala Para, Shaktigarh, P.S. - N.J.P., Dist. Jalpaiguri, I do here by want to inform you as follows :-

1. That my daughter namely Nishita Saha aged about 18 years is a student of Delhi Paramedical Management Institute, doing the course of Nurshing at the said Institute.
2. That from past few days I am noticing that my daughter is behaving weird and mostly is keeping silent and scary.
3. That I whenever asked my daughter about the said behavior my daughter used give some excuses but yesterday when I was checking her android mobile being No. 8391869166, I found that one person namely **MD. SAHAJAHAN**, S/O Md. Rahaman, Resident of Porajhar, P.S. Medical Out-Post under Matigara Police Station has being repetitively called various time through the his mobile Phone bearing No. 9609572860 upon the mobile phone of my daughter and when I enquired my daughter about the said incident my daughter started crying and screaming with fear.
4. That after few days the said person **MD. SAHAJAHAN** started to threat my daughter that he has recorded my daughter's voice and will circulate it within the society if I don't meet with him and also forced my daughter to send some private pictures and on this my daughter got scared as the said person **MD. SAHAJAHAN** threaten my daughter that if I tell this fact to anyone then he will kill my family members.
5. That after getting the said pictures the said **MD. SAHAJAHAN** constantly was blackmailing my daughter to meet with him and force her to get sexually intimated.
