Sir,

In reference to the above, I am forwarding herewith the arrested accused persons namely (i) Md. Tamanna (28) s/o Md. Majibul Haque of Sukantapally, Gas Godwan, Ward No- 46, PS- Matigara, Dist- Darjeeling (ii) Sujan Bardewa (28) s/o Lt. Santosh Bardewa of Bijan Bari, PS- Pul Bazar, Block- Bijanbari, Dist- Darjeeling a/p Mangrajoite, Dagapur, PS- Pradhan Nagar, Dist- Darjeeling (iii) Sunil Tamang (23) s/o Shankar Tamang of Milan More, Sishudangi, PS- Pradhan Nagar, Dist- Darjeeling (iv) Kamakhya Majumdar (36) s/o Gopal Majumdar of Gurung Basti, Ward No- 03, PS- Pradhan Nagar, Dist- Darjeeling A/P Bagajatin Colony, Lane No.- 45/5 PS- Siliguri, Dist- Darjeeling (v) Arjun Chettri (25) s/o Nar Bahadur Chettri of 4th Mile, Panik Busty, PS- Kalimpong Sadar, Dist- Kalimpong A/P Uttarayan, Himachal Bihar, PS- Matigara, Dist- Darjeeling before your Id court along with all connected papers under proper police escort. The ground of arrest duly been communicated with them.

I beg to report before your good office that today on 29.12.2022 received a written complaint from SI Ajay Pradhan of NJP PS, Siliguri Police Commissionerate beg to the effect that on 28.12.2022 SI Ajay Pradhan along with force detailed to perform night RT van Duty under New Jalpaiguri PS, Siliguri Police Commissionerate vide New Jalpaiguri PS MCC No 1478 dated: 28.12.2022. Today on 29.12.2022 at 0115 Hrs while performing RT night van duty he received a secret source information that a gang of miscreants come to below Rupchand Gach, near Jatiyakali, Dokan Gora More, under PS- NJP, Dist- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Rupchand Gach, and Jatiyakali and Kalangini. Accordingly, he informed the fact to you as well as Asstt Commissioner of Police, East-II, SPC and diarized the fact in General diary vide NJP PS GDE No 1294 dated 29.12.2022. As per kind order and direction of superior officer he along with force namely C/1018 Santosh Biswakarma & NVE/0071-Parimal Roy left for Jatiyakali More to verify the verisity of the information. In the mean time, he request Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate to provide more force to assist during the raid. Hence, VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawant Roy, CV/116 Rohit Kr Mahato and CV/B24 Niru Yadav came to Jatiyakali more to assist him to work out the information in hand. At about 0145 hrs on 29.12.2022 they arrived at Dokan Ghora More, Rupchandgach, near Jatiyakali More, under New Jalpaiguri PS under New Jalpaiguri PS. At about 0215 hrs we found that 10/11 persons assembled in a dark place at Dokan Ghora More, Rupchandgach, near Jatiyakali More, under New Jalpaiguri PS and they were whispering in a very low voice. Accordingly they cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 05 (Five) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. On search of the apprehended accused persons SI Ajay Pradhan found (i) One sharp cutting Sabol & One Bhojali & One Blunt Iron Rod from the possession of accused Md. Tamanna (28) s/o Md. Majibul Haque of Sukantapally, Gas Godwan, Ward No.- 46, PS- Matigara, Dist- Darjeeling (ii) One sharp cutting Sabol, One Small Iron Rod length 25 Inch found from the possession of accused Sujan Bardewa (28) s/o Lt. Santosh Bardewa of Bijan Bari, PS- Pul Bazar, Block- Bijanbari, Dist- Darjeeling (iii) One Iron made sabol, One Torch Light from the possession of accused Sunil Tamang (23) s/o Shankar Tamang of Milan More, Sishudangi, PS- Pradhan Nagar, Dist- Darjeeling (iv) One Iron made Hasua, Screw Driver from the possession of Kamakhya Majumdar (36) s/o Gopal Majumdar of Gurung Basti, Ward No.- 03, PS- Pradhan Nagar, Dist- Darjeeling A/P Bagajatin Colony, Lane No.- 45/5 PS- Siliguri, Dist- Darjeeling (v) One Bhojali, One Iron Rod from the possession of Arjun Chettri (25) s/o Nar Bahadur Chettri of 4th Mile, Panik Busty, PS- Kalimpong Sadar, Dist- Kalimpong A/P Uttarayan, Himachal Bihar, JPSO- Matigara, Dist- Darjeeling. Accordingly, SI-Ajay Pradhan seized the above noted weapon of offence under proper seizure list and arrested the above noted 05 (Five) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure made in between 0255 hrs to 0345 hrs on 29.12.2022.

During investigation of the case I thoroughly interrogated all the 05 (Five) arrested accused persons and during interrogation they admitted their guilt and disclosed that they along with others 10/11 persons of their associates assembled at Rupchandgach, Dokan Gora, near Jatiyakali More, under New Jalpaiguri PS, Dist- Jalpaiguri for committing dacoity at Jatiyakali, Rupchandgach, Kalangini.
