Sir,

I Sri Subhadeep Banerjee, S/O Sri Debasish Banerjee posted as Divisional Engineer, Siliguri Town Division would like to inform you that on 29.12.2022 evening it was reported to me by the owner of Tesla Food Industries (Mob-9832326675) that suspected theft of oil has occurred from the Distribution Transformer in their premises. On receiving such information via phone, I immediately sent the HT Mobile Van Staffs to attend the complaint at site. On inspection it was reported that oil theft has occurred from the Transformer.

It is consecutive twice that the incident has taken place in the premises leading to such financial & commercial loss to the department. A total of 415 Lts of oil has been theft involving a financial loss of Rs. 37,343/-(approx.).

You are requested to lodge the complaint & investigate the matter accordingly.
