With due respect, I am producing herewith one arrested accused persons namely Kishore Kumar Roy of Baribhasa Madasni Bazar PS New Jalpaiguri Dist- Jalpaiguri under arrest along with some articles under seizure. The ground of arrest duly been communicated with him.

- (01) (Six) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
- (01) (Eight) bottles of Kingfisher strong premium beer containing 650 ml in each bottle

I, the undersigned, presently attached with NJP PS under your kind control beg to state that on 20/12/2022 at about 10:00 hrs I received a secret source information that one persons namely Kishore Kumar Roy of Baribhasa Madasni Bazar, PS-New Jalpaiguri, Dist- Jalpaiguri is selling ID liquor at his shop at Baribhasa Madasni Bazar at his shop, PS-NJP, Dist- Jalpaiguri. As a result, I learnt of the fact in the General diary vide NJP PS GDE No. 1377 dated 30/12/2022 and mentioned the fact to you. As per your kind direction and instruction myself along with VP/001 (Senior) i.e. VP-1 (General) Smta V/106 Biswajit Roy, CV/B24 Niru Kumar Yadav all of NJP PS, SPC, I of Baribhasa Madasni Bazar, PS- NJP Dist- Jalpaiguri to work out the information in hand. At about 20:15 hrs we arrived at Baribhasa Madasni Bazar under New Jalpaiguri PS, Dist- Jalpaiguri and being assisted by the Senior Field rand at the resident of the said accused and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of above sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest complying all the formalities of arrest. The whole process of search & seizure was made in between 20:15 hrs to 20:45 hrs on 30/12/2022.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Kishore Kumar Roy (P.U) S/o Rashik Roy of Baribhasa Madasni Bazar, PS-New Jalpaiguri, Dist- Jalpaiguri and arrange for its investigation.
