That on 11.2023, at about 1:00 am morning my son
namely Bishal Sahani was celebrating Happy New
Year, at that time suddenly one person namely
Rabi Kamti, s/o Baij Nath Kamti who is our neighbour
came and started abusing them in filthy languages
and when my son tried to restrain him he
started assaulting my son and then my son
- Bishal Sahani cried for help and hearing his hue
and cry, I rushed from my room to save him
and I went there to save my son Bishal Sahani

at that time father of Rabi Kanti, ie Baijnath Kanti
(1) Bansa his wife Gayatri Kanti and brother of
Baijnath Kanti, Deepak Kanti and wife of Deepak Kanti
Asha Kanti also came there with sword in his
hand and iron rod in the hand of Deepak
Kanti and bamboo in the hand of Rabi Kanti
and with intent to murder my son and tried
to hit him with sword on his neck and seeing
this I launched myself from his hand
and then Baijnath Kanti (Bansa) and Deepak Kanti
from behind assault me and tried to molest
me and torn my wearing apparels and hit
me with bamboo and iron rod in the hand of
Deepak Kanti hit me with intent to murder me
and then Gayatri Kanti also hit me on my
head with bamboo and thereafter they all
threw me from river bank on the river bed
due to such fall I became unconscious seeing
this my son Bishal Sahani went to the house
of neighbours and tried for help and they

gathered there and seeing them they fled away from there and I was taken to the Bageloger hospital by the neighbour, and was I admitted in Bageloger hospital and the doctors had referred me to N B M C Hospital for further treatment and advise me to do X-ray and CT scan due to such assault. I received severe injury on my left leg, neck, hand, hand finger and my son also got injured. I am suffering from severe body pain and head pain and I am in critical condition and fighting from death. While fleeing away they took away my wearing ornaments, gold chain and ring.

So, Sir, I request you to kindly take necessary legal action against the aforesaid person for the commission of the said offence by them upon us.
