entered my house and forced me to  
buy some white powder to clean floor.  
First I denied but they put some red  
powder on my neck and wrist and I  
lost my conscience. On semiconscious  
stage they took my gold chain (necklace)  
24 carate, 4 tolas and bracelet (Churo)  
24 carate, 4 tolas and ran away.

Therefore, I request you to take  
needful action to arrest the culprits.
