Advocate along with vokalatnama and photo copy of some documents against the opposite party mentioned in the petition for the committing offence as stated in the said petition praying for direction upon the IC, Pradhan Nagar PS for registering this application as FIR and investigate into the matter.

On perusal of the facts of the said application and perusal of the documents enclosed by the petitioner in support of his prayer it appears to this Court that information is tendered to the Commissioner of Police, SPC, Siliguri. Ld. Advocate submitted that the IC, Pradhan Nagar PS has informed the petitioner that the incident as alleged did not occur under his jurisdiction. It is not for the petitioner to trace out the correct jurisdiction. There is a concept of zero FIR. The petitioner can seek to lodge the FIR at any police station and no police station can refuse to accept the FIR stating that the offence did not occur under the jurisdiction of However, I find it proper to direct the IC, Pradhan Nagar PS to conduct a preliminary enquiry as to the allegations.

The IC, Pradhan Nagar PS is hereby specifically directed to submit a preliminary report by 21.01.2023.
