Respected Sir,

With due respect, I beg to state that I Dr. Jishnu Sankar Roy Basunia, S/o. Late Mahesh Chandra Roy Basunia alongwith my wife Smt. Debaleena Roy are absolute owners of a total land measuring about measuring 0.08 Acre, recorded in R.S. Khatian No. 08, appertaining to and forming part of R.S. Plot No. 178, corresponding to L.R. Plot No.- 436, Present L.R. Khatian No.- 3936 & 3937, under Mouza - Kawakhari, J.L. No. 72, Police Station - Matigara, District - Darjeeling and we have all documents of ownership in respect of such property including deeds, Khatian, conversion certificate etc..

Sir, since December i.e. on 20/12/2022, when we have entered into the aforesaid property for the purpose of some construction works, some renowned landgrabbers of the said locality including 20/12/2022, Niren Singha, Nuken Singha, Upen Singha, Bablu Singha, all are sons of Sri Niren Singha, all are resident of Kawakhari, Medical More, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, W.B.-734012 have come to our land and demanded huge money from me else they will not allow me to make construction and they will grab our land in our absence.

Thereafter on 26/12/2022, in our absence, the above named persons along with their men and persons forcibly tried to capture the suit land by breaking the boundary walls, I have raised strong protest and could restrain them.

Finding no other alternative, I alongwith my wife Smt. Debaleena Roy have jointly filed a civil suit along with injunction application against said Niren Singha, Nuken Singha, Upen Singha, Bablu Singha, in the Court of Ld. Civil Judge Junior Division at Siliguri being Title Suit No. 04/2023 and said application for temporary injunction was moved on 02/01/2023 and after hearing Ld. Court was pleased to allow the prayer for ad-interim injunction and restrained the defendants from disturbing the peaceful possession of the plaintiffs (i.e. Dr. Jishnu Sankar Roy Basunia and Smt. Debaleena Roy) in respect of the above mentioned land.

In spite of order of the Ld. Court, the above named Niren Singha, Nuken Singha, Upen Singha, Bablu Singha and Others have been continuously disturbing us and they are disregarding the order of Court.

Therefore, I request you to take necessary legal action against said Niren Singha, Nuken Singha, Upen Singha, Bablu Singha, all are sons of Sri Niren Singha, all are resident of Kawakhari, Medical More, P.O. -Sushrutanagar, P.S. Matigara, Dist. Darjeeling, W.B.-734012 and also to see that the order of Ld. Court may not be violated by them.
