Sir.

With due regard and humble submission I Pankaj Prasad, resident of Sova Bhawan, Buddha Mandir Road, Durga Nagar Colony, Ward No-III, P.O & P.S- Pradhan Nagar, Siliguri, Dist- Darjeeling do hereby submit the following for your kind perusal and necessary action :-

1. That I have purchased Two Commercial Vehicle for my livings in Finance from Bank being Registration No- WB 73E 5039 and WB 73E 6589 .
2. That out of the Two vehicle I have already cleared the Finance and I am paying still paying the installment of one Vehicle by taking loan from my friends.
3. That Sri Prabhat Roy took my above mentioned Vehicle with the Promise /condition that he would pay me Rs. 18,000/- per month in the Month of August 2022 and promise to make written Agreement of the said two Vehicles and I on good faith I provided him the said two Vehicle .
4. That said Prabhat Roy paid me Rs.10,000/- on 30th August 2022 and Rs. 20,000/- on 27th September 2022 and promised to pay the remaining amount on 12th November.
5. That on 12th November 2022 failed to pay and informed me that my said vehicle is damaged and will pay within one week but all in vain.
6. That on 13th November I meet Prabhat Roy at Rajgunj and I came to know that my one Vehicle being No- WB 73E 6589 is seized by Rajgunj Police in connection with one Case and my said vehicle is damaged .
7. That I requested Prabhat Roy to return dues and my other Vehicle being No WB73E 5039 but he did not paid my dues and made excuses and always promise that he would return soon but in vain.
8. That Prabhat Roy have cheated me and have committed Criminal Breach of Trust with me and have kept me in dark for his ill motive.
9. That I have come to know that Prabhat Roy have committed Criminal Breach of Trust with several people and he always cheat people by making false statements by bluff them for his ill motive and have come to know that he have also cheated to some persons of Siliguri by making false promises.
10. That I am in doubt that Prabhat Roy might sell /dispose off my said vehicles or can involve the said vehicles in any antisocial act/activities /drugs activities or any crime for his illegal gain/ill motive and the whereabouts of my other vehicle being No WB73E 5039 is not known .

Under the above fact and Circumstances you are requested to please legal steps into the matter and help to recover my said vehicles & money for which I shall be highly oblige and tale legal action Prabhat Roy acceding to law who have cheated me and committed criminal breach with me .
