With due regard and humble submission I Suraj Kumar Gupta S/o Sima Devi, resident of Rajendra Nagar, Ward No-1, P.O & P.S- Pradhan Nagar, Siliguri, Dist- Darjeeling do hereby submit the following for your kind perusal and necessary action :-

1. That my mother namely Sima Devi is the registered Owner of a HYUNDAI EON ERA+ Car , being Registration No WB 72T 7936, being Engine No- G3HAJM576960, Chassis No MALA251ALIM623461 .
2. That I am Handicap and unable to move frequent and hence I have kept one driver namely Prabhat Roy S/O Ramesh Roy, resident of Dakshin Khattimari, Dist- Jalpaiguri, Presently residing at Rajgunj Dist- Jalpaiguri, on monthly basis for my conveyance in the month of September.
3. That on 29th September Prabhat Roy requested me for loan of Rs. 30,000/- informing me that his wife is seriously ill and he promise that he would return back within one month and on good faith I provided him the said amount of Rs. 30,000/- and in the evening he took my said vehicle to his house informing that he would return on the next date.
4. That on 30th September 2022 i.e. on the next day I called Prabhat Roy over his mobile No 8293553259 to bring back my said car and he told that his wife is serious and would return after 2 days.
5. That on several times I requested Prabhat Roy to return my said car over mobile and he always made excuses and always promise that he would return soon but in vain.
6. That Prabhat Roy have cheated me and have committed Criminal Breach of Trust with me and have kept me in dark for his ill motive.
7. That I have come to know that Prabhat Roy have committed Criminal Breach of Trust with several people and he always cheat people by making false statements by bluff them for his ill motive.
8. That I am in doubt that Prabhat Roy might sell /dispose off my said car or can involve the said vehicle in any antisocial act/activities /drugs activities or any crime for his illegal gain/ill motive.
9. That Prabhat Roy is continuously from 26/12/22 threatening me by mobile No- 7602593165 and today on 30/12/22 at about 7:18 P.M he threatened me that he would murder/ Kidnap me & my family members from house if I lodge any complaint against him at any police station and no one can do anything as police is in his hands.

Under the above fact and Circumstances you are requested to please look into the matter and help to recover my said vehicle & money for which I shall be highly oblige and take legal action against Prabhat Roy according to law, who have cheated me and committed criminal breach with me and continuously threatening to murder/kidnap.
