Sir,  
With due respect I Smt. Sima Majumder Chhetri, D/O - Bikash Chhetri,  
W/O Sri Utam Majumder, Presently residing at Partram Jole, Shanti More,  
P.O. and P.S. Matigara, Dist - Darjeeling, do hereby want to inform you as  
follows :-

1. That I was married to Sri Utam Majumder, S/O Late Dijen Majumder,  
R/O Adarshnagar Colony, Ward No. - 4 of S.M.C., Mahamanda Para,  
P.O. Siltguri Bazar, P.S. - Khalpara Fari, District - Darjeeling, on  
16.01.2011 and after the said marriage I started to live with my in laws  
at my matrimonial home at the above mentioned address.
2. That from the first day of my marriage I gradually reveal that my husband  
is a habituated drunker and addicted to gambling. Subsequently after  
realizing the fact whenever I tried to protest the same my husband used  
to constantly torture upon me and let me down in every aspect in the  
house. My husband often used to insult me in front of all the family  
members and neighbors and when I tried to protest the same my  
husband used to beat me cruelly and used to shut my mouth so that I  
could not express the matter to my parents. My husband used to protest  
home in a drunken condition every day and all the time I tried to protest  
him he beaten me in front of all my in laws.
3. That from the beginning my parents tried their level best to fulfill all the  
demands of my husband but my husband and in laws never ever  
satisfied with them. Rather his demand increased day by day and he  
used to create such helpless situation so that my parents became bound  
to fulfill their demands. Moreover my husband always used to pressurize  
my parents to give him money and whenever I protest such kind of  
behavior he used to beat me mercilessly.
4. That my husband and mother in law also took all the stridhan from me  
and always used to insult me for not bringing that much dowry as per  
their demand. Moreover whenever my parents did not fulfill the demand  
of my husband my husband and in laws always used to torture me and  
pressurize me for bringing more dowry from my parents. This is to  
mention here that my husband is addicted gambler and always took  
some of his friends in home and started to drink and gamble inside the  
house and whenever I tried to protest such kind of behavior of my  
husband he always insulted me in front of all and also used to beat me  
mercilessly and also torture me mentally and physically. I was spending  
my life with him with a hope that one day everything will be alright but  
that was in vein.

5. That subsequently my mother in law started to pressurize me to do some work and earn money for my livelihood and subsequently in the month of March 2012 I joined one private job and started to work there. Moreover at that time my husband took several loan from several persons and started to pressurize me to repay the said loan taken by my husband. Whenever I tried to protest such behavior of my husband he used to be violent and torture me mentally and physically.
6. That subsequently I gave birth of a male child on 17.06.2013 namely Pratim Majumder. My husband and in laws were never ever happy with the child and after his birth they stopped to provide food and other necessary requirements to me and my infant baby. At that time I used to spend day in a starving condition without the essentials of livelihood with a hope that everything will be alright in future. Being in such a fatal situation I somehow managed to brought up my baby.
7. That subsequently after the rice ceremony of my son my husband and mother in law took all the gifts and gold ornaments as well as Kasha utensils, which was received during the rice ceremony. Moreover my mother in law and husband never given those article for the use of my son and whenever I tried to protest them they used to insult me and my infant baby and also torture me mentally and physically.
8. That subsequently in the year of 2016 my husband took me in a rented house at Pati Colony and after shifting there my husband became more adamant and started to consume more alcohol and gamble inside the house. Whenever I tried to protest such kind of behavior of my husband he always used to beat me mercilessly. Thereafter due to the most adamant behavior of my husband and non payment of rent we again shifted to out matrimonial house in the month of September 2019 but after shifted in my matrimonial house the level of torture increased and my husband started to torture me mentally and physically to bring more money for him.
9. That subsequently in the month of February of 2020, my husband and in laws thrown me out of my matrimonial house along with my child and also threatened me that they will not allow me in my matrimonial house and at that time I became bound to leave my matrimonial house left behind all my necessary belongings and stridhan properties.
10. That subsequently my husband started to come to my paternal house in a drunken condition and create a great chaos there and demand money from my parents on several occasion.

11. That this is to mention here that on 08.07.2022 my husband came to my parental house and started to create great chaos there and demanded that he wants the custody of my child. Moreover he also assured that he will return my child after few days and he wants to spend some time with his child out of his fatherly love and care. At this he took my child from my parental house, but irrespective of passing several days my husband nor return my child to me nor he allowed me to meet my child. Subsequently on several occasion I tried to communicate with my child but my husband and my mother in law never allowed me to meet my son. Moreover my son is a student of class IV of Margaret School and at present his education is hampered due to the fatal situation in that house and he also became severally ill on several times. Moreover whenever I tried to meet my son my husband and my mother in law abused me in filthy languages and also threatened me that they will never ever allow me to take the custody of my son and they also thrown me forcefully from my matrimonial house.
12. That lastly on 02.01.2023 my husband came to my paternal house in a drunken condition at about 09.30 P.M. and started to create a great chaos there and stated to abuse me and my parents in filthy languages. At that time my husband also threatened my father to give him money and also abused me in filthy languages and tried to beat me with fist and blows, at this when my father tried to resist him from his acts and conducts my husband became violent and beat me father. At this when we all started to shout and the local people started to gather inside the house then my husband fled away.

Under the above mentioned situation I request you to kindly look after the above mentioned matter and take the necessary legal action as soon as possible to protect our life and dignity because at present I am living in a very dangerous situation as my prestige has already been destroyed by the acts of my husband.
