On routine inspection, I, Suman Sengupta, DE & SM, Power House CCC along with Sanjay Prasad, Sr. Office Executive, Power House CCC visited the premises of consumer, HAIDAE ALI, ISKON MANDIR ROAD, GITAL PARA, P.O- SEVOKE ROAD, DIST- JALPAIGURI, SILIGURI bearing Consumer Id: - **400013797** & Energy Meter No: - **A1000920178651** (Make- CMS, 240v, 5-30 Amp. Single Phase) having a Domestic connection. The site being at ISKON MANDIR ROAD, GITAL PARA, P.O- SEVOKE ROAD, DIST- JALPAIGURI, SILIGURI. We entered the consumer premises on 06.01.2023 at 12:28 Hrs. On inspection it was found that the meter was not present physically on the site. The Price of the missing item is Rs 1089/- (approx), other than the actual units consumed and are to be billed yet. We exited the premises on 12.45 Hrs.
