Subject: F.I.R regarding Damage of the Property of WBSEDCL

Respected Sir,

I, Suman Sengupta, Son Of Ashoke Sengupta, Divisional Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electrical equipments, property of WBSEDCL. At Around 9:30 PM on 05.01.2023 night Power House Customer Care center received information regarding damage of electric equipments and accessories in Pradhan Para, near Sanskriti, Salugara, Dist Jalpaiguri, P.S Bhaktinagar Siliguri. On reaching the site, it was found that a Vehicle, had severely damaged one 11/0.440KV, 160 Kva Distribution Transformer along with the 11Kv XLPE incoming cable, with oil leaking from the DTR body. Prima facie it was reported by the local people that the vehicle with vehicle no WB78 4851(ph no- 8603299237) had damaged the Transformer. The vehicle was also found on site. Photographs attached. The total damages caused by the vehicle are approximately around Rs 247451/- (Rupees Two Lakhs Forty Seven Thousand Four hundred And Fifty One Only).

Thus you are requested to kindly initiate an investigation against the driver of the vehicle no WB78 4851 under Section 139 of the Indian Electricity act 2003 amended on 2007.
