Respected Sir/Madam,

With due respect, I Bapi Banik, S/o. Dipak Banik, R/o. Sukanta Nagar, Ward No.38, P.S. Bahaktinagar, Dist. Jalpaiguri, would like to inform you that when I was coming from my home to Siliguri Court on my Motorcycle and in between near Gouri Bhawan, Mangal Pandey Sarani, Hakimpara, ward no. 15, P.S. Siliguri, Dist. Darjeeling, at around 10:00 to 10:30 am, three (3) persons namely, 1) Bikram Das @ Lallan, S/o. Late Chanchal Das, 2) Gopal, S/o. not known, both of them are R/o. Megahnath Sarani, Hakimpara, ward no. 15, P.S. Siliguri, Dist. Darjeeling, and 3) name not known, restrained me without any reasons used filthy languages and during that aforesaid incident the above noted persons without any reasons demanded a sum of Rs. 50,000/ (Rupees Fifty Thousand) only from me and I also noticed that all of them were in intoxicated condition and when I denied to fulfill their demand at that time the above noted persons showing me one sharp cutting weapon (knife) and putting me fear of death and after taking advantage of the same they started to beat me very badly and also after putting me in fear of death they forcefully took away my Gold Chain (15gm approx.) along with cash Rs. 65,000/ (Sixty five thousand) approx. from my possession and after that they fled away from the spot, and it is important to mention here that due to assaulted by them I sustained multiple injuries on my whole body, specially on my neck thereafter, due to help of my well-wishers, I was treated at Siliguri Sadar Hospital.

Therefore, I request you to kindly take necessary legal action against them as soon as possible.
