I BIKAS JAIN S/o Shri Madan lal Jain resident of agrasen road Ward No. 9 P.O and P.S Siliguri, Dist Darjeeling I do here by lodge this F.I.R to the effect stating that my elder brother is the elected representative of people of ward no 9 of Siliguri Municipal corporation as present councillor and He is also the leader of opposition of Siliguri Municipal Corporation.and I do here by lodge this F.I.R to the effect stating that yesterday on dated-02-01-2023 at above-10.30 P.M my brother got information by some local people of ward that some people have gathered near sriram paradise resturent beside Gandhi maidan and they are createing dispute among themselves,then my brother Amit jain reached that place with our ward committee member named Lal chand jaiswal son of Late Shankar Prasad jaiswal .They saw that EX councilor (ward no-9) of T.M.C party Pradip goyal@ kalu son of sri Ram kumar Agarwal standing with some people carrying Bamboo stick, iron-rod and wooden batam and pradeep kr goyal was carrying wodden batam in his hand they stopped my brother's scooty,when Amit jain wanted to know from them the matter suddenly pradeep kr.goyal@kalu started abusing them and he also assaulted my brother AMIT JAIN with wooden batam which was in his hand and their after he asked his other accomplices/anti-social namely 1.)vijay choudhury son of Late Nand kishore choudhury 2) Manoj gupta son of shri uma Shankar gupta 3) Rahul garg@ricky son of shri Subhash garg to hit My brother as well as lal ch. Jaiswal .Then Vijay choudhury,manoj gupta and Rahul garg@ricky. the instigation and provocation those persons also assaulted my brother and other ward committee member lal ch jaiswal who was with my brother by bamboo stick and iron rod resulting in serious and grave injury and lal ch jaiswal both of them were injured on chest ,stomach, head, leg and hip with an intention to kill them as well as lal ch jaiswal. When my brother Amit jain failed out then Pradip kumar goyal@kalu snatched the golden chain from my brother neck,golden finger ring from hand as well as stole Rs.10,000 (rupees ten thousand) from the pocket of my brother, in this incident they also tore his clothes.my brother Amit jain and lal ch jaiswal both of them were

taken to District hospital by the resident of ward and They have been admitted for treatment and the doctor has advise for admission in the hospital for futher few days and if there is no improvement in their injury condition

then we might be shifted to N.B.M.C.H. the condition Of my brother is very serious at present to I am lodging this F.I.R and I have full knowledge of the incident as I and my father also reached the spot when the assault was being committed by pradip kumar goyal@kalu,vijay chaudhury and Rahul garg@Ricky and his other anti-social group

So sir I pray before you to kindly register this F.I.R and take strong and immediate legal action against and their associate.
