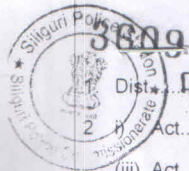

In this regard I, SI Mrinmoy Ghosh presently posted as Officer In Charge of Khalpara TOP-II under Siliguri PS, SPC do hereby lodge complaint against the above noted fourteen arrested accused persons and approx 30 others male & female supporters of BJP Darjeeling District Committee , Siliguri to the effect that on 03.01.2023 at about 17.30 hrs about 50 supporters of BJP Darjeeling District Committee started a rally without any permission from Venus More under Siliguri PS SPC under the leadership of 1) Anandamoy Barman MLA, Matigara Naxal Bari Assembly , 2) Shri Durgamurmu MLA, Phansidewa Assembly 3) Nantu Pal leader of BJP Siliguri, 4) Bikas Sarkar leader of BJP Siliguri, 5) Shalini Dalmia, councilor Ward No. 8 Siliguri Municipal Corporation, under the banner "DHIKKAR MICHIL" in this regard officer and force were already deployed at Venus More Vide L/O CC No. 10/01/23 Date. 03.01.2023 corresponding Siliguri PS GDE NO. 138 Date. 03.01.23.

Subsequently when the rally reached at Venus More through Sevok More, under the direct supervision of ACP, DD.SPC. Shri Rajen Chhetri, Inspector Shri Kesang Lama SPC, I/C Siliguri PS SPC we stopped the rally near the Venus More Traffic Point but the members of BJP party under the leadership of 1) Anandamoy Barman MLA, Matigara Naxal Bari Assembly , 2) Shri Durgamurmu MLA, Phansidewa Assembly 3) Nantu Pal leader of BJP Siliguri, 4) Bikas Sarkar leader of BJP Siliguri, 5) Shalini Dalmia, councilor Ward No. 8 Siliguri Municipal Corporation got unruly and tried to break the Police cordon and also tried to deter me and other on duty officers and force on their lawful duty. Then we started addressing the unruly mob and tried to negotiate with them in order to keep the traffic flow and Law & order situation normal. But the unruly BJP members under the leadership of 1) Anandamoy Barman MLA, Matigara Naxal Bari Assembly , 2) Shri Durgamurmu MLA, Phansidewa Assembly 3) Nantu Pal leader of BJP Siliguri, 4) Bikas Sarkar leader of BJP Siliguri, 5) Shalini Dalmia, councilor Ward No. 8 Siliguri Municipal Corporation got more furious and in order to break the Police cordon. Finding no alternative we started to push them off and at the same time we directed them to maintain peace and not to obstruct public road and free flow of traffic. But the unruly leaders and members of BJP did not pay any heed to our wards. They continue to deter on duty Police personnel from their lawful duties and broke the Police cordon and they under the leader ship of 1) Anandamoy Barman MLA, Matigara Naxal Bari Assembly , 2) Shri Durgamurmu


Murmu MLA, Phansidewa Assembly 3) Nantu Pal leader of BJP Siliguri, 4) Bikas Sarkar leader of BJP Siliguri, 5) Shalini Dalmia, councilor Ward No. 8 Siliguri Municipal Corporation and started blocking the free flow of the traffic at Venus More. Then they forcefully started stopping the vehicles moving to their respective directions and started staging agitation aimlessly.

On reinforcement finally we detained them at the Venus More and arrested them accordingly after narrating the ground of arrest. Thereafter other supporters of BJP started to leave Venus More carelessly and aimlessly and brought them to Siliguri PS.

Now I request you to start a specific case under proper section of law and take proper legal action against the arrested accused persons namely 1] Atanu sarkar (37/m), S/O- Mukunda Bihair Sarkar of Rupsingjote, Gosaipur, PS- bagdogra, Dist- Darjeeling 2] Rajeev Kumar(36/m), S/O - Asrafi Roy of Ashoknagar, ps- Bagdogra, Dist- Darjeeling 3] Manish Gupta(32/m), S/O - Lalon gupta of 1 no main road, Upper Bagdogra, ps- Bagdogra, dist- Darjeeling 4] Bikash Sarkar(53/m), S/O-Bhasan Ch.
