Binod Gupta (35/M) S/O- Layman Gupta of Gurungbusty, Ward No. 3, PS- Pradhannagr, Dist- Darjeeling who were brought under arrest under proper arrest memo to the effect that on 03.01.2023 I had an information in hand that approx 50 supporters of BJP Darjeeling District Committee , Siliguri going to organized a rally without any permission under the banner "DHIKKAR MICHIL" from 17.30 hrs onwards in this regard officer and force were deployed at Venus More form SPC Head Quarter Vide L/O CC No. 10/01/22 Date. 03.01.2023 corresponding Siliguri PS GDE NO. 138 Date. 03.01.23.

On the same day at 17.30 hrs approx 50 supporters of BJP Darjeeling District Committee started rally from Venus more under the leadership of 1) Anandamoy Barman MLA, Matigara Naxal Bari Assembly , 2) Shri Durga Murmu MLA, Phansidewa Assembly 3) Nantu Pal leader of BJP Siliguri, 4) Bikas Sarkar leader of BJP Siliguri, 5) Shalini Dalmia, councilor Ward No. 8 Siliguri Municipal Corporation started the rally from Venus More at 18.25 hrs the said rally under the leadership of above noted BJP leaders reached at Venus more and after reaching at Venus more the supporters of said rally became unruly and started blocking the road and started blocking the free flow of the traffic at Venus More staging agitation aimlessly

Accordingly they were stopped and they started behave unruly and tried to break the Police cordon by force and also tried to deter me and other on duty officers to deterred to discharge on their lawful duties. Then we started addressing the unruly mob and tried to negotiate with them in order to keep the traffic flow and Law & order situation normal. But the unruly BJP members under the leadership of 1) Anandamoy Barman MLA, Matigara Naxal Bari Assembly , 2) Shri Durga Murmu MLA, Phansidewa Assembly 3) Nantu Pal leader of BJP Siliguri, 4) Bikas Sarkar leader of BJP Siliguri, 5) Shalini Dalmia, councilor Ward No. 8 Siliguri Municipal Corporation got more furious and obstructed on duty police personnel i.e me and others in order to break the Police cordon. On reinforcement finally we detained some of them at the Venus More and arrested them accordingly after narrating the ground of arrest. Thereafter other supporters of BJP including 1) Anandamoy Barman MLA, Matigara Naxal Bari Assembly , 2) Shri Durga Murmu MLA, Phansidewa Assembly started to leave Venus More aimlessly and they also tried to board on a Police vehicle forcefully.

After clearing the road blockage at Venus More and dispersing the BJP Supporters alongwith the arrested persons returned to Siliguri PS and At around 18.45 hrs as we returned to PS I then received an information that approx 30 BJP Supporters of Darjeeling district started blocking the road in front old Ananda Loke Cinema Hall, Station Feeder Road under Siliguri PS SPC. accordingly myself along with SI. Kamal Biswas, SI. Basu Guha K-21 Patrolling Van officer and force rushed to the spot.

On arrival at the spot I found that BJP leaders 1) Anandamoy Barman MLA, Matigara Naxal Bari Assembly , 2) Shri Durga Murmu MLA, Phansidewa Assembly who organized a rally without permission at Venus More today arrived in front of old Ananda Loke Cinema Hall at Station Feeder Road under Siliguri PS SPC along with 25 supporters stopped a Police vehicle and started blocking S.F Road Siliguri and caused hindrance in free flow of traffic.


On arrival at the spot we tried to make them understand that the act which they were doing is illegal and at that time of conversation they became more aggressive and the unruly BJP members under the leadership of above noted BJP leaders got more furious and tried to restrain on duty police personnel doing their lawful duty to maintain free flow movement of traffic and others in order to blocking the road. Thereafter finding no other option on reinforcement finally we detained them at S.F Road and arrested them accordingly after narrating the ground of arrest and brought them PS. Subsequently after returning PS maintained all formalities the all detained persons are released on bail on surety of one Trideep Saha S/O. mrinal Kanti Saha of Subhash Pally Ward No. 18 PS. Siliguri Dist. Darjeeling Ld. Advocate for the detained persons.
