Sub: FIR against Pilferage of Electricity

Sir,
I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that *Mr. Subhas Ghosh, S/O- Shibnath Ghosh, resident of Rathkhola (Ward No.- 22), P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412026421),* has committed Theft of Electricity under section: 135(i) (b) & (c) of the Electricity Act, 2003, read with further amendments for the Domestic purpose as stated here under.

On 04.01.2023 at about 13:10 Hours, I, Sri Sourav Paul, AE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Arnab Ray, J.E. (E) (Grade-II) & 2. Mr. Umesh Subba, Sr. TSH., attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of the accused person, *Mr. Subhas Ghosh, S/O- Shibnath Ghosh, resident of Rathkhola (Ward No.- 22), P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412026421),* in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection it has been found that the aforesaid accused, *Mr. Subhas Ghosh, S/O- Shibnath Ghosh, resident of Rathkhola (Ward No.- 22), P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412026421),* was consuming Electricity dishonestly in unauthorized manner by *Tampering Incoming Service Cable before entering the Meter Incoming Terminal & Tapping-off Electrical Energy from the Tapered portion of the said Service Cable by PVC Cable & Bypassing the proper metering arrangement by connecting other end of the Tapping wire to the house's own wiring arrangement (i.e. Switch Board system) avoiding metering circuit to run various appliances (e.g. Light, Fan, Refrigerator, TV set, Water Pump, Inverter & AC machine) at his aforementioned Domestic premises for Domestic purposes having Accessed/Inspected Load 2.683kW. Hence the meter was unable to record the proper/exact Electrical Energy consumption. Thus WBSEDCL incurred huge amount of loss in revenue.*

As Theft was detected I immediately with the help of my Technical staff disconnected his unauthorized Service Connections and seized some portion of *Two No., Single Core, Black Colour, PVC Insulated Aluminum Tapered Service Cable, having approx. size of 6.0SQMM each & approx. length 1.5 Meters each (Tapered portion of Incoming Service Cable) jointed with some portion of One No., Black Colour, Single Core Stranded PVC Insulated Copper Wire, having approx. size of 1.5SQMM & approx. length of 0.5 Meter (Tapping Wire) which has been used for Tapping-off Electrical Energy from the Tapered portion of the said Service Cable before entering the Meter Incoming Terminal & Bypassing the proper metering arrangement (Meter Serial No: H311544, make: HEPL, LR: 12276 kWh) of WBSEDCL dishonestly in unauthorized manner by connecting the other end of the Tapping wire to the house's own wiring arrangement (i.e. Switch Board arrangement) avoiding metering circuit to run various appliances at the mentioned Domestic premises (Phase line was taken from the Tapered portion of Incoming Service Cable & Neutral line was taken from the Local Earth) under a proper seizure list duly signed by the Inspection Team Members & Witnesses & the Accused Person & his local witness i.e. Daughter. The seized articles were properly packed, labeled and sealed at the spot in presence of the Inspection Team Members & Witnesses & the Accused Person & his local witness i.e. Daughter. The inspection team members left the aforesaid premises at 13:55 Hours on the same day after observing all formalities.*

So the accused *Mr. Subhas Ghosh, S/O- Shibnath Ghosh, resident of Rathkhola (Ward No.- 22), P.O. - Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412026421),* has committed Theft of Electricity under section: 135(i) (b) & (c) of the Electricity Act, 2003, read with further amendments for the Domestic purpose.

So I request you to take cognizance on this matter and consider this complain as FIR to initiate further necessary action from your end.
