I Lopamedra Bishnu, daughter of Gosai Pada Bishnu resident of Pipeline, South Deshbandhu Para, Siliguri would like to inform you that I was in a 10 year relationship with Subham Siddhanta resident of Ambika Chakraborty Sarani, South Bharat Nagar. He continuously threatened me that he might commit suicide if I leave him. He is an alcoholic and after consuming alcohol he yells at me, calls bad names, throws abuses and whenever we have a fight he becomes very aggressive. He tries to control everything I do, wants to track my location. Though he said he will stop being an alcoholic but after all these 10 years of mental pressure I chose not to stay with him anymore. He is sometimes very caring and loving and again very aggressive. I fear his aggressiveness and don't want to entertain his controlling attitude anymore. I want to end this relationship completely. And if he tries to commit suicide or commits it I will not be responsible for it. I don't want any form of communication with him or any of his family members or his friends or anyone related to him. He says irrelevant things on phone and I have a few recordings. He also have my pictures, voter Id picture, Aadhar, Pan, class X and XII documents pictures on his laptop and mobile and I don't want him to mis use those. I want him to be safe and away from me.
