Sir,

In producing herewith two arrested persons namely (i) Kashif Mahfuz Shaikh (24), S/O Mahfuz Shaikh of Chiraia Mahesh Bethna, P.O. - Chiraia, P.S. - Baisi, Dist. - Purnia, Bihar and (ii) Kudrat Ali (26), S/O Md Sakir of Charia Khas, P.O. - Chiraia, P.S. - Baisi, Dist. - Purnia, Bihar along with all relevant documents, seizure list and seized articles viz Five (05) tied nylon sacks having two (02) paper boxes in each and each box contains total hundreds (100) bottles of 100 ml. Rx. Chlorpheniramine Maleate & Codeine Phosphate Cough Linctus, registered named of "PHENSEDYL®" COUGH LINCTUS having Batch Nos.: PHC22165, PHC22166, PHC22167, PHC22172 Mfg. Date: Aug. 22, Expiry Date: Jan. 26, MRP Rs.: 205.31/- each. Total 1000 bottles x 100 ml. = total 100 litter. Each sack duly sealed and labeled as Ex. "A", "B", "C", "D" and "E" individually and taken one bottle at random as sample from each sack and labeled as Ex. "A1", "B1", "C1", "D1" and "E1" respectively which are recovered and seized from the joint possession of said Kashif Mahfuz Shaikh and Kudrat Ali.

I, SI Dipankar Goswami, of Pradhan Nagar PS Siliguri Police Commissionerate do hereby lodge this written complaint against above noted Kashif Mahfuz Shaikh and Kudrat Ali to the effect that on 08.01.2023 at 18.20 hrs, I received a reliable source information that two persons of Bihar are waiting at Tenzing Norgy Bus Terminal, Siliguri Junction, P.S. - Pradhan Nagar, Dist. - Darjeeling along with huge consignment of cough syrup for its disposal clandestinely. The matter has been diarized vide Pradhan Nagar PS, GDE No. 425 Dt. 08.01.2023 and I informed you as well as superior officers about the information in hand. As per your direction myself along with S.I. Ahishekh Theengh, ASI Manoj Roy, ASI Ashit Kumar Singh, CV/128 Ajay Kumar Sahani, CV/645 Pankaj Gupta, CV/242 Rakesh Mongar, CV/646 Baban Das all of Pradhan Nagar PS Siliguri Police Commissionerate left P.S. vide Pradhan Nagar P.S. M.C.C. No. 65/23 Dt. 08.01.2023 G.D.E. No. 426 Dt. 08.01.23 by Govt Vehicle bearing no. WB-74AC-9851 to verify the veracity of the information. At the time of departure from the P.S., I took envelope, white paper, sealing wax, gum, seal, official stamp, stamp pad and other all necessary requirements for the spot at Tenzing Norgy Bus Terminal, Siliguri Junction. On way to Tenzing Norgy Bus Terminal I called two independent witnesses from Siliguri Junction namely (i) Ashok Singh (45) S/O Lt. Ramdayal Singh of Dharam Nagar, Ward No. 1, P.S. - Pradhan Nagar, Dist. - Darjeeling and ii) Debendra Singh (40) S/O Sri Ram Pratap Singh of Beldangi, Tumbajote, P.S. - Matigara, Dist. - Darjeeling and informed them in writing about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary. Accordingly, they become agreed to be a witness of the case.

At about 18.55 hrs, we arrived at Tenzing Norgy Bus Terminal, Siliguri Junction under Pradhan Nagar P.S. and as pointed by the source we meticulously cordoned off the alleged two persons who are possessing five (05) loaded and tide nylon sacks. Seeing our team both the accused persons tried to flee away from the spot but our team managed to apprehend them. On being asked the apprehended persons disclosed their name and identity as noted above. On further asked about contains of sacks which they were possessing, they admitted that there are cough syrup bottles in the sacks. On demand they failed to produce any valid documents

or paper for possessing such cough syrups. Then we detained them with strong reason to believe that the said persons are illegally possessing the contraband drugs inside the sacks and trying its clandestine disposal. After disclosing our identity, I asked them in writing whether they wanted to be searched in presence of Executive Magistrate or Gazetted Officer for the process of search and they agreed to be searched by any one of the two. Accordingly, I served them a notice in accordance with provisions of law in this regard and read it out and explain the same and they have given their consents verbally.


Subsequently, I contacted with videographer namely Somnath Chatterjee and asked him to come to the spot immediately and make videography of whole process of search and seizure. I also contacted with Sri Manabendra Rakshit, Assistant Commissioner of Police, Enforcement Branch, Siliguri Police Commissionerate who has been detailed as Executive Magistrate in Siliguri Police Commissionerate area for today and requested him to come to the spot and supervise the entire process of search and seizure as per law. Accordingly, Sri Manabendra Rakshit, ACP (EB), SPC arrived at the spot at 19.20 hrs. thereafter the process of the search was started. Before conducting search, self-search of me and Sri Manabendra Rakshit, ACP (EB), SPC had been conducted by the detained person and they could not find any offending things except our personal belongs and I.O. kit. Then, I commenced the search of the five (05) nylon sacks which was possesses by above noted Kashif Mahfuz Shaikh and Kudrat Ali jointly and found above mentioned cough syrup bottles inside the sacks as described in seizure list. On further demand they failed to produce any valid document/paper in respect of the recovered Cough Syrup and they stated that they are selling huge quantity cough syrup at Bihar and Siliguri area and one Mansur Ali of near Charia High School, P.O. - Chiraia, P.S. - Baisi, Dist.- Purnia, Bihar is the supplier of the cough syrup and other persons also involved with them. Accordingly, I packed, sealed and labeled the recovered articles separately after keeping samples of cough syrups for laboratory examination and seized the same by preparing proper seizure lists in presence of independent witnesses as mentioned above and said Kashif Mahfuz Shaikh and Kudrat Ali and obtained their signature in the seizure list and label as well. The entire search, seizure, label process made between 19.45 hrs and 21.00 hrs and video graphed by videographer Somnath Chatterjee. It is seen that all the articles found as mentioned above are prescription drugs which falls under NDPS Act and liable for punishment as per its provision. Hence, having strong reason to believe that they were committing the offence under provision of NDPS Act I arrested the above noted Kashif Mahfuz Shaikh and Kudrat Ali by preparing memo of arrest and took them under my custody and brought to police station with the assistance of my accompanying team.

The arrested accused Kashif Mahfuz Shaikh and Kudrat Ali have committed the offence under NDPS Act and liable for prosecution as per its provision. Hence, I request you to kindly register a specific case against said Kashif Mahfuz Shaikh, Kudrat Ali, Mansur Ali and others and arrange for its investigation.


