Respected Sir,

I Sushil Barman, s/o Late Basanta Barman, resident of Village-Tumba Jote, P.O. & P.S. Matigara
would like to bring to your information:

1. That I have filed Writ Petition - W .P.O. No. 2439 of 2022 in the High Court at Calcutta.
2. That on 20/12/2022 respondent has served documents to my advocate at Kolkata.
3. That on 24/12/2022, I received documents from my advocate through speed post, Speed Post No. EWL277503971IN posted on 21/12/2022.
4. That while going through the above set of Documents I am surprised to see that I have submitted an affidavit dated 22/09/2021 declaring that I have no required bank balance in my bank account to set up and run the F.P. shop dealer ship. I am not eligible candidate to get F.P. Shop license as well as I have no objection if the Non-Worker F.P. Shop of Matigara Tea Garden licenses is granted to Smt. Babita Singha Barman, I shall not file any legal suit/writ petition before any court of law.
5. After seeing the above affidavit, I tried to contact my advocate at Kolkata so what further steps to be taken but due to vacation of Christmas, I could not contact my advocate.
6. After the vacation is over I could contact my advocate and came to know that one advocate Sri Subhankar Das has also submitted documents to my advocate on behalf of Smt. Babita Singha Barman, wife of Sanjit Singha and two others.
7. While going through the said documents I found that the above said affidavit as well as one declaration, submission of NOC and application for transfer of Dealership (F.P.) shop in favour of Smt. Babita Singha Barman dated 24/09/2021 has been submitted by me.
8. But as I have never filed or submitted above narrated affidavit dated 22/09/2021, as well as the above said declaration cum NOC and application for transfer of Dealership (F.P.) shop in favour of Smt. Babita Singha and came to know that I should lodge information to the Police.

Sir, I further Inform you that I have submitted an affidavit dated 23/09/2021 declaring that if the License will be issued in my name than I shall not file any legal suit/writ petition before any court of law.
