

In producing herewith the following 04 (four) persons arrested namely 1. Deb Das@ Kanai (M/21) S/O- Monoranjan Das of Dasharath Pally, W.No-44, P.S-Bhaktinagar, Dist-Jalpaiguri, 2. Samir Sarkar@ Ganesh (M/23) S/O- Lt Ajit Sarkar of Dasharath Pally, W.No-44,PS-Bhaktinagar, Dist-Jalpaiguri 3. Prosenjit Biswas @ Kuranu (M/25) S/O- Subhash Biswas of Sorojini Pally, W.No-42, PS-Bhaktinagar, Dist-Jalpaiguri 4. Raju Saibo @ Ladi (M/23) S/O- Dhanilal Saibo Sorojini Pally, W.No-42, PS-Bhaktinagar, Dist-Jalpaiguri under arrest along with the following seized articles:-

1. One iron made knife measuring about 18 cm" in length recovered from the possession of accused Deb Das@ Kanai (M/21)

2. One iron rod measuring about 37" in length recovered from the possession of accused Samir Sarkar@ Ganesh (M/23)

3. One iron rod measuring about 35" in length recovered from the possession of accused Prosenjit Biswas @ Kuranu (M/25)

4. One iron rod measuring about 33" in length recovered from the possession of accused Raju Saibo @ Ladi (M/23)

I, SI Rantu Haldar of Bhaktinagar PS/SPC would like to lodge this written complaint against the above noted persons and 4/5 others persons to the effect that today i.e on 10.01.2023 at about 00.15 hours when myself along with, SI Sajal Roy, C/986 Rajib Sarkar, C/1431 Dilip Barman CV/014 Labanyamay Barman was performing night mobile duty at that time received a secret source information that a group of 08/09 persons had assembled at near TB Hospital under Bhaktinagar P.S with deadly weapons with a view to commit some heinous crime. Accordingly without waste any time I informed the matter to I/C Bhaktinagar PS over telephone and as per telephonic instruction we rushed to the spot to verify the veracity of the information and to work upon it. On way to the P.O I called one disinterest independent witness namely 1. Prakash Biswakarma S/O- Dhan Bahadur Biswakarma of Bhupendra nagar, W/N-42, P.S- Bhaktinagar, Dist- Jalpaiguri whom we disclosed our motto and identity and asked him to accompany us if any search and seizure is necessary for the purpose. We reached near the spot as directed by the source at about 00.45 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement at about 00.55 hrs and found a group of 08/09 persons sitting there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 04(four) above referred accused persons. On interrogation the 04(four) persons disclosed their identity as noted above and confessed 4/5 other persons with them. They had assembled there with a view to commit dacoity after making full preparation

in the house of Dasharath Pally adjacent areas. Thereafter all the apprehended persons were searched in presence of the witnesses and the above noted articles were searched.

All the articles were seized between 01.35 hrs to 02.05 hrs issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested between 02.05 hrs to 02.15 hrs as they had assembled for committing heinous crime.

Under the above circumstances, I pray before you that a specific case U/S 399/402 I.P.C may kindly be started against the 03 (three) persons arrested namely 1. Deb Das@ Kanai (M/21) S/O- Monoranjan Das of Dasharath Pally, W.No-44, P.S-Bhaktinagar, Dist-Jalpaiguri, 2. Samir Sarkar@ Ganesh (M/23) S/O- Lt Ajit Sarkar of Dasharath Pally, W.No-44, PS-Bhaktinagar, Dist-Jalpaiguri 3. Prosenjit Biswas @ Kuranu (M/25) S/O- Subhash Biswas of Sorojini Pally, W.No-42, PS-Bhaktinagar, Dist-Jalpaiguri 4. Raju Saibo @ Ladi (M/23) S/O- Dhanilal Saibo Sorojini Pally, W.No-42, PS-Bhaktinagar, Dist-Jalpaiguri and 4/5 other persons for assembling with deadly weapons with a view to committing dacoity.
