Sir,

With due respect I P.S.I. Biswadeb Barman do hereby lodge this complaint against one arrested person namely Tm Mohammad Jaffar Ahamed (Male/24 years), S/O Md. Abdul Mazid, of Thoubalv Moijing, P.S. & Dist. - Thoubal, Manipur to the effect that, today i.e. on 10.01.2023 at around 14.00 hrs in course of mobile van duty vide Pradhan Nagar P.S. G.D.E. No. 533 Dt. 10.01.23 I found one Maruti Suzuki Star VXI Car having Registration No. WB-42N-2015 is coming from Darjeeling More side towards Champasari More in a suspicious driving motion. To avoid any untoward incident, I managed to intercept the vehicle at Champasari More Traffic Crossing with the assistance of on duty traffic personnel and found the above noted arrested persons is driving the car. On demand said arrested persons can only produce his Indian Union Driving License having no MN06 20200002712 issued from Licensing Authority, Imphal East, Manipur and one Agreement of Sale in support of the vehicle. On suspicion I went to ARTO Office, Siliguri to verify the genuinity of the driving license and ownership of the vehicle from the concern office. The Licensing Authority (ARTO), Siliguri verified the ownership and license having no MN0620200002712 and supplied a certified copy of license no MN0620200002712 to me and it learnt that, the license was issued to one Oscar Ningombam Manimohan as per official online record. Later, on being asked the driver admitted that, he procures the fake driving license from Imphal, Manipur and using the same since last two years for driving vehicles nationally. Thus, I seized the fake license having No MN06 20200002712 in the name of said arrested person, the Maruti Suzuki Vehicle WB-42N-2015 and its Agreement of Sale and arrested the above noted person u/s 41 Cr.P.C. for prosecution as per law.

I therefore, pray before you to kindly register a specific case against arrested persons namely Tm Mohammad Jaffar Ahamed under proper section of law and arrange for its investigation.
