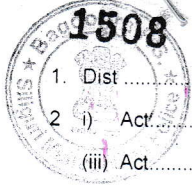

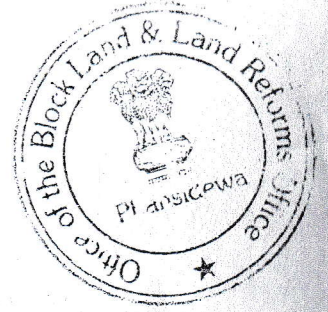

Regarding the above subject and reference, the followings are for your kind knowledge:

1. The undersigned has apprehended illegal encroachment of Plot No. 3 of Mouja: Bhaisdubi, J.L. No. 12 having an area of 12.73 acres and informed the same to you in the above referred letters.
2. During regular verifications it reported to the undersigned yesterday that, the said Amit Agarwala Foundation has constructed a temporary structure over the earmarked area for distribution of pattas and erased the marks and also erected a signboard in favour "Amit Agarwala Foundation". This is a act of unauthorized encroachment of Government vested land in contravention of court orders.
3. It is worth noting that, the structure and the sign board was erected after 28.12.2022 as a survey was conducted by this office on 28.12.2022 on the suit plot.

Hence, you are requested to treat this letter as a FIR against the said "Amit Agarwala Foundation" and take necessary steps in accordance with law.
