F.I.R

Dear Sir,

This is to report you that during the darkness of night some unknown miscreants have been regularly entering into the premises of our Association, by crossing over the backside Boundary Wall of our premises (they have damaged some portion of the Boundary wall) where the Employees' Quarters are situated. Sometimes, the miscreants also enter during day time - and it seems from their appearance/gesture that they are Drug Addict.

It has been informed to the undersigned by Sri Om Thapa, Office Boy of our Association that today morning at about 7.00 AM he has noticed that yesterday night (i.e. 10.01.2023) some unknown miscreants entered into the quarter of the Secretary (now vacant) by breaking the doors and had stolen the wooden windows of the kitchen, main switch, water pipelines and electrical equipments like bulbs, tube lights, electrical wiring, switch etc. The miscreants had also stolen the tins from the roof of the adjacent garage.

We have intimated to your goodself about the situation of this area from time to time over telephone and also lodged the following F.I.Rs, copies of which are enclosed herewith for your ready reference (but there is no improvement in the situation and the rank outsiders have been trespassing into our Office premises regularly, doing all sorts of anti-social activities and pilfering our valuable properties):-
