Respected Sir,

with due respect I would like to inform you that I Sri Nirangan Mondal & Sri Ramesh Mondal resident of Bhakti Nagar, Ward No. 35 of Siliguri Municipal Corporation, P.O. Bhakti Nagar, P.S. N.S.P. Police Station.

That on 8/1/2023 at about 11.00 P.M. when I was returning home from the medicine shop "Tripti Medicine" where I am working as staff, some miscreants dashed into my vehicle causing severe damage to my vehicle at word No. 20 near Anshok Bhattacharya's residence. In fact the scooter like <sup>vehicle</sup> bearing number vide WB74 B95867 was in rough and high speed and intentionally ravaged my vehicle. Due to the speedy dash they I fell down from my vehicle and instantly when I reacted to the matter they started assaulting me with Iron Rod, bamboo and punches.

That immediately when I resisted them they snatched a sum of Rs 6000 (Six thousand). At the time of snatching I resisted but they hurted my head with bamboo stick, to which I fell down and was left unconscious for few moments. As it is winter season there were none to save me from them. But after sometime a passerby somehow rescued me and escorted me to my home.

That due to this reason I would like to inform and lodge a complaint regarding the above stated matters, I would be ever grateful to you if you kindly take necessary action and do the needful.
