I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Mukesh Kr. Singhal & Anil Kr Singhal, Sarodamoni Road, Ashrampara, Opposite Of Prachi Apartment, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 09.01.2023 at about 03.30 p.m. acting on a source information I, along with 1) Sri Amarasish Mahandeo, DE(E), S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Sudipta Moitra, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Mukesh Kr. Singhal & Anil Kr Singhal and inspected service installation, metering installation of Consumer ID 412207648 in the name of Mukesh Kr. Singhal and Consumer ID 412234554 in the name of Anil Kr Singhal. During inspection it was found that user Mukesh Kr. Singhal supplying electricity from the energy meter of Consumer ID 412207648 unauthorisedly and illegally to the disconnected & defaulted premises of Consumer ID 412234554 in the name of Anil Kr Singhal that was disconnected previously on 19.08.2016 due to non-payment of outstanding energy bill.

As unauthorised supply of electricity to the disconnected & defaulted premises was detected the energy meter make Landies & Gyer Ltd, serial no.- L3314161 installed against Con Id. 412207648 seized by preparing a formal seizure list duly signed by representative of Mukesh Kr. Singhal and witnesses. The copy of the seizure list handed over to representative of Mukesh Kr. Singhal and his signature obtained as token of receipt.

As Mukesh Kr. Singhal & Anil Kr Singhal have committed offence u/s 135(1)(e) & 150 of Electricity Act 2003 by supplying electricity illegally & unauthorisedly to the disconnected & defaulted premises, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
