Imtiaz @ Somu @ Dulare is also absent from her house and her said parents & elder sister admitted that Sabiya Khatun has been taken away by Md. Imtiaz @ Somu @ Dulare to some unknown place, with their consent.

So, it is crystal clear that my said minor daughter has been kidnaped by the main culprit namely (1) Md. Imtiaz @ Somu @ Dulare, with the help of his parents and elder sister noted above. The mob. No. of main culprit Md. Imtiaz is 838808179 is switched off since then.
