Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Asrafal Hoque (26) S/O- Md. Israil of Raghobpur, PO- Altapur, PS- Karandighi, Dist- Uttar Dinaj pur (ii) Alirul Hoque (35 yrs) S/O Najir Hossian of Do and the following articles under seizure :-

1. One Mahindra Pick UP having registration number WB/59/B/1414 loaded with 04 (Four) numbers of big size cattles in different colour.

I, ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 10.01.23 at 19.15 hrs I received a secret source information that one vehicle having registration number (i) WB/59/B/1414 loaded with stolen cattles which were procured by stolen or fraudulent means are coming from Ghosh pukur side. Accordingly, I informed the fact to O/C, NJP PS and dirised the fact in general diary vide NJP PS GDE No- 431 dated 10.01.2023 and as per order myself along with VP/08 Laxman Roy, VP/13 Jamirul Islam, CV/306 Biswajit Roy left for Fulbari Toll Plaza to work out the information in hand. At about 19.35 hrs we arrived at Fulbari Toll Plaza and started to Naka checking in order to intercept the said vehicle. At about 20.15 hrs we noticed that the above noted vehicles coming from Ghosh Pukur side. We managed to intercept above noted vehicle at Fulbari Toll Plaza. On verification we found two persons are seating inside vehicle No WB/59/B/1414 they disclosed their identity as (i) Asrafal Hoque (26) S/O- Md. Israil of Raghobpur, PO- Altapur, PS- Karandighi, Dist- Uttar Dinaj pur (ii) Alirul Hoque (35 yrs) S/O Najir Hossian of Do and on search it is found that 04 (four) numbers of cattles in different colour loaded in the said vehicle, On demand they failed to produce any valid documents/purchase invoice in respect of carrying cattles in their respective vehicles. They also failed to produce any permit for carrying livestock in the vehicles and also failed to produce any medical check up certificate in respect of such cattles which is a mandatory provision of law before transporting of cattle. I also asked them to produce any supporting documents in respect of carrying/transporting the cattle if any but they failed to produce the same. During further interrogation they admitted that cattles were procured by some cattle smugglers by illegal means from Bihar side in order to supply the same to Assam to make huge profit.

During physical verification, it is found that the cattles were loaded in such a manner which caused unnecessary pain and suffering to those cattles as there was no reasonable space/opportunity for their movement.

I then seized the above noted One Mahindra Pick UP having registration number WB/59/B/1414 loaded with 04 (Four) numbers of big size cattles in different colour. under proper seizure list and arrested the above noted two accused persons namely (i) Asrafal Hoque (26) S/O- Md. Israil of Raghobpur, PO- Altapur, PS- Karandighi, Dist- Uttar Dinaj pur (ii) Alirul Hoque (35 yrs) S/O Najir Hossian of Do under proper memo of arrest and observing all the formalities of arrest for possessing and transporting the cattles which is reasonably belived to be stolen property and for causing unnecessary pain and suffering to the cattles. The search and seizure made in between 20.25 hrs and 21.10 hrs.

Therefore, I request you that a specific case under proper section of law may kindly be initiated against the above noted arrested accused persons namely (i) Asrafal Hoque (26) S/O- Md. Israil of Raghobpur, PO- Altapur, PS- Karandighi, Dist- Uttar Dinaj pur (ii) Alirul Hoque (35 yrs) S/O Najir Hossian of Do and arrange for its investigation.
