(2) 12 (Twelve) bottles of Kingfisher strong Beer each bottle containing 650 ML which was kept in one big nylon hand bag.

I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 11.01.23 at 18.05 hrs received a source information from Gandhinagar more under Bhaktinagar PS that one person namely Mahadeb Dey has gathered huge quantity of liquor in his street shop at Gandhinagar More style as 'Samir Hotel' for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-521 dated 11.01.23. As per your kind instruction myself along with ASI Dipak Karmakar, CVF/014 Labannomoy Barman, CVF/614 Sumit kumar Roy, C/Dilip Barman proceeded to the PO to work out the information. At 18.20 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his street shop which was kept in the shop of him. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him u/s 41 Crpc after issuing proper arrest memo (The seizure was made in between 18.25 hrs to 19.20 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Mahadeb Dey @ Kaley-33yrs s/o Lt Dilip Dey of Gandhinagar More. ward No-43, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
