That after the death of my father Late Ashish Chakraborty my abovenamed uncles are running the Renuka Mandap business in full swing but they are not providing any statements of accounts since the month of April 2020 and it is apprehended that they are misappropriating the income of the said Renuka Mandap Business and syphoning the fund for their illegal gain. Notice asking statement of account was sent to my uncles but they have not provided any reply till date, which amply speaks of their illegal activities by not providing the accounts of Renuka Mandap business. Further, my two-year minor child has been subjected to cruelty by their constant disturbances and even I am being restricted with regard to ingress and egress to our residential premises as my uncles are trying to drive me out from my parental home for the reason that I have already been married.
5. That today about 10.00 A.M when I, approached my uncle Ashoke Chakraborty with regard to the accounts of said Renuka Mandap business, he and his other family members abused me again and threatened with life if I tried to interfere in the internal matters of the said business.
6. That due to such abovementioned activities of my abovenamed uncles, I, along with my brother, widow mother and infant child is highly traumatized and finding it extremely difficult and alarming to reside at our abovementioned residence and also to enjoy and avail our right of our property.


