I, **SADDAM HUSSIAN**, son of Md.Abdulla, resident of Champasari more, Adnandamoyee, P.O. & P.S. Pradhan nagar, District – Darjeeling would like to inform and request you as follows:-

1. That I am law abiding citizen of India.
2. That yesterday at 6:30p.m. I along with my friends went for outing and one of our friend Ankit Das, S/O Ashim Das took of scotty of his father being no.WB74Az8638 with us.
3. That due to the shortage of fuel,I along my friends enter into Bharat Petrol Pump,Champasari,siliguri,wherein the staff of petrol pump namely i) Lal Mohan of ward No.46 of S.M.C. ii) Sikandar@ Radhe and iii) Modi started to misbehave with me and with my friends.
4. That the above named staffs of the said petrol pump suddenly started abusing us with filthy languages and started assaulting me and my friends with iron Rod, Sticks and injured me badly on my ear and head.
5. That the above named staffs also snatched a amount of Rs.4000 from my wallet and also had destroyed my friends scooty no.WB74AZ8638.
