Sir,

In producing herewith one accused person namely Roshan Barman (M/20yrs) S/O- Ramani Barman of Roy Colony, Chayan Para, W.No- 42, P.S- Bhaktinagar, Dist- Jalpaiguri in custody and the following property under seizure along with seizure list:-

- i. 15 (Fifteen) Bottles of RECODEX-DX Cough Syrup each bottle containing 100 MI having Composition Chlorpheniramine Maleate IP 2mg, Dextromethorphen Hydrobromide IP 10 mg total weight 15X100 MI= 1.5 Ltr and Marked as exhibit- "A"
- ii. 06 (Six) Strips of PROXYCO-SPAS capsules each strips containing 24 Capsuls total 24X6= 144 Capsule Having composition Dicylomine Hydrochloride IP 10 mg, Tramadol Hydrochloride IP 50 mg, Acetaminophen IP 325 mg and marked as Exhibit B
- iii. One white colour carry Bag in which Seized article (Sl No- 1&2) is kept inside the bag.

I, SI Rantu Haldar S/O- Monoranjan Haldar of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 12.01.2023 at 17.05 hrs received a secret source information that one person having possession of huge quantity of Narcotics Substances in his possession without valid documents and selling to the addicted young boys and school /college going students at near Goodrick School for Special Education, Don Bosco more under PS- Bhaktinagar. Accordingly the information was diarized vide BKN PS/SPC GDE No. 565 Dtd. 12.01.2023 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with, SI Sajal Roy, SI Srimanta Chaterjee, C/1431 Dilip Barman, C/915 Chandra Prakash Adhikary, CV/619 Dharmendra Roy, all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No-39/23 Dt. 12.01.2023 to verify the veracity of information corresponding BKN PS/SPC, GDE.NO. 566 Dated. 12.01.2023 At the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 13.05 hrs on arrival there I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Binod Subba (M/44) S/O- Lt Tirtha Bahadur Subba of near Satya Vikash School, W.No-42, P.S- Bhaktinagar, Dist- Jalpaiguri, and (ii) Amit Chandak (M/44) S/O- Lt Arun Chandak of Don Bosco More, Zila Parisad Road, W.No-42, P.S- Bhaktinagar, Dist- Jalpaiguri also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness. At about 17.45 hrs as shown and identified by the source, we found one person was standing near Goodrick School for Special Education, Don Bosco more under PS- Bhaktinagar with one carry bag and we detained the above noted person along with above noted articles which was kept in his right hand inside the hand bag. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person

stated that he is carrying and possessing "Narcotics Substances" with him. Then I asked him whether he wanted to be search in presence of an Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and apprehended person to search our Police Party as per provision. But they refused to search by the police party. Then I informed the matter to special Executive Magistrate and requested him to come at near Goodrick School for Special Education, Don Bosco more under PS-Bhaktinagar to remain present and supervise the search and seizure as he being a special Executive Magistrate. After some time Special executive magistrate Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC arrived at the spot. I disclosed the identity of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC to the apprehended person and witnesses as a Special executive magistrate. Thereafter under the supervision Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC and in presence of him and independent witnesses I conducted search of the above apprehended person keeping strict regard and found the articles as per seizure list in a carry bag which was possessing/carrying by the apprehend person. On being asked he further confessed in presence of Special executive magistrate and other witnesses that he procured the Narcotics Substance clandestinely for the purpose of selling to his designed Customers in order to earn huge amount of money for his wrongful gain. On interrogation he disclosed that he has been dealing in such illegal drug trafficking business and selling the same to the adjacent area of Bhaktinagar PS. On examination of the alleged apprehended person noted above regarding any documents for carrying/possessing of said Narcotics Substance he failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC I seized the articles under proper seizure list and Label under the supervision of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC in presence of witnesses duly signed by them as well as the accused person and marked the seized exhibits as noted above.


The seizure and label was made between 18.55 hrs to 19.45 hrs. The whole process of search and seizure was video graphed. Then I arrested the above noted accused person u/s-41 Cr.P.C after observing all formalities of arrest and disclosed them cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged person under proper receipt as the alleged accused person violated the terms and condition of N.D.P.S Act possessing Brown Sugar without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely Roshan Barman (M/20yrs) S/O- Rathani Barman of Roy Colony, Chayan Para, W.No- 42, P.S- Bhaktinagar, Dist- Jalpaiguri and Others and arrange for its investigation.
