Shatadal Roy ,Presently (Age-10), my mother in law and her sons increase torture day by
day and my husband said that the child is not my side and also said that this child is bong to
some one else's and after birth of my girl child Name- Jayashri Roy (presently age -6 years
old) years, my mother-in-law and my husband, also her brother increase cruelty extremely
mentally as well as phisically .
