I would like to further inform you that after the said transfer as stated aforesaid, I continued to avail the said bank account service including ATM Card & Credit Card service within the jurisdiction of Siliguri and I have been continuing to maintain the said savings account as usual and I started to make my necessary bank transaction out of the said savings bank account through the S.F. Road branch of the said bank at Siliguri as the said branch is nearest to my husband's office.

I would like to further inform you that the said credit card account number was attached with the mobile number of my husband. On 05.11.2022 my husband received two different messages in his mobile device (being mobile no. 9475260644) regarding two transactions / credit through Paytm of a sum of Rs. 40,698.98/- and Rs. 39,681.48/- respectively.
