I, the undersigned would like to draw your kind attention towards the fact that one Rahul Parakh, Son of Meghraj Parakh, partner of M/S Builders Gallery, residing at 2<sup>nd</sup> floor, Shiv residency ,Sukanta Sarani Road, Milanpally, Siliguri, Dist.- Darjeeling, Pin Code-734005, Mobile No. +91 98009-35555, +91 99330-44448, in the year 2018 he approached me at my Siliguri Residence and requested me for financial assistance for the purpose of his business development and after several persuasions by him, his elder brother Dr. Prince Parakh and his father I provided him with financial assistance to the tune of Rs. 10,00,000/- (Rupees Ten Lacs) only in the month of August, 2018 and further Rahul Parakh promised me to repay the said sum within a period of 6 months.

The said sum of money was transferred directly to the bank account of the said Builder's Gallery via RTGS. The said sum was transferred to him from my bank account being Account No. 11749307735 maintained by State Bank of India, Changrabandha Branch to his bank account being Account Number: 01517630000233 having IFSC Code: HDFC0000151 maintained with HDFC Bank Ltd., Sevoke Road Branch on two separate occasions that is on 27.08.2018 and 29.08.2018 respectively and made payments of Rs. 5,00,000/- in both the occasions.

That it is pertinent to mention here that no payment was made by the said Rahul Parakh during the period of 6 months. I have requested him several times to return the sum taken by him as assistance but each and every time he circumvented me by making false excuses and kept asking Page 1 of 4

more time for the payment. Rahul Parakh willfully neglected to repay the sum taken by him.

The dues of the said Rahul Parakh amounting to Rs. 10,00,000/-(Rupees Ten Lacs) only is unpaid till date.

That I am an aged person suffering from heart disease and several other ailments. That recently when I asked them to pay me the sum taken Rahul Parakh straight away denied to pay me any moneyand furthermore him alongwith his father Meghraj Parakh have threatened me with dire consequences that if I ever come to them and ask any money then they will make sure that I shall not live to see the morning of the next day.

That Rahul Parakh's elder brother Dr. Prince Parakh has good hold over Police administration and politicians and they will implicate false cases against us and will make sure that me and my family will rot in jail. Rahul Parakh, his elder brother Prince Parakh and their father Meghraj Parakh have also threatened me and my family members with dire consequences.

Rahul Parakh's brother Prince Parakh is a very influential person having very strong connections and I will never be able to do anything to them. Rahul Parakh along with his father Meghraj Parakh and his elder brother Prince Parakh have hatched up this ugly conspiracy to cheat my money and deprive me and cause me financial loss.

That from the very inception the said Rahul Parakh and othershad the mensrea to cheat and misappropriate my legitimate claim and cause me financial loss and from his acts it is clear that he has ulterior motive and intention to deprive me from my legible dues and cheat me and misappropriate my legal claims.

Therefore, I would like to request you to start a specific case under the suitable provisions of law against the said Rahul Parakh, his elder brother Prince Parakh and their father Meghraj Parakh so that the culprits could be punished accordingly under the suitable provisions of law.
