Sir,

With due respect and in producing herewith the arrested accused person namely Parba Barman (49), S/O Lt. Balai Barman of Baniakhari, Tripalijote, PS - Matigara, Dist- Darjeeling with following seized articles :-

- > One vehicle Truck bearing Reg. No. WB 73 E 0815 Loaded with river bed materials (Stone).

In this regard, I ASI Sanjay Basunia of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person to the effect that on 13.01.2023 at about 14:05 hrs onwards I received a source Information that one vehicle one vehicle Truck bearing Reg. No. WB 73 E 0815 loaded with river bed materials (Stone) coming from Baswhbari Ghat side without any valid documents. Accordingly I inform the fact to Officer In charge, Matigara PS and as per his kind direction myself along with force had been to Bashbari Ghat under PS Matigara to work out the information in hand. After arrival of the spot I found said vehicle Truck bearing Reg. No. WB 73 E 0815 loaded with river bed materials (Stone) standing at Basbari Ghat under Matigara PS area. Accordingly, I apprehended the driver of the vehicle. On demand he failed to produce any valid documents in respect of river bed materials (Stone) loaded in his vehicle. On further interrogation, he stated that he mines such river bed materials (Stone) from Bashbari Ghat by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above noted vehicle loaded with illegally mining river bed materials (Stone) under proper seizure list and arrested him after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Parba Barman (49), S/O Lt. Balai Barman of Baniakhari, Tripalijote, PS - Matigara, Dist- Darjeeling or the owner of the vehicle and arrange for its investigation.
