I, MANIKA DAS BISWAS, wife of Sri. Kamal Das,
resident of Vill. Kawakhal, P.O. Sushrutnagar, P.S.
Maligara, Dist. Darjeeling, would like to inform you
that I have one daughter namely PUJA BISWAS
aged about 14 years who reside along with us at my
above mentioned residential address. One BAPI
MALPAHARI, son of MAGU MALPAHARI, resident of Vill.
P.O. Gossainpur, P.O. & P.S. Bagdogra, Dist. Darjeeling has
been stalking my minor daughter since 2 to 3
months. He even tried to contact my daughter
through mobile phone on numerous occasions.

I and my husband even informed and complaint
these incidents to his parents but in vain. I
understood that said Bapi use to do these with
the support of his parents. That on 26.12.2022
at about 5.00 P.M. when I went to a local
market said BAPI MALPAHARI kidnaped my
daughter in my absence from my house. We
searched every possible places but could not find
her. On 14.01.2023 I came to know from local
people that said BAPI had come to my house
on that day from when she was missing. Thereafter
I, my father, my Elder and younger sister visited
said BAPI'S house for rescuing my daughter but
I my daughter was not present. On our questioning
said (i) MAGU MALPAHARI s/o. Unknown, (ii) BAPI'S
BROTHER-IN-LAW s/o. Unknown, (iii) BAPI'S Elder Sister
w/o. Unknown and (iv) Three miscreants (Unknown)
attack upon us as a result my father and my
Elder Sister received several injuries on their
Persons. Now they are under treatment.

I therefore, request you to kindly take
necessary legal steps against those culprits and kindly
rescue my daughter from their hands.
