Sir,

In producing herewith the following seized articles as per proper seizure list viz:
(1) 15 (Fifteen) bottles of Himalayan Gold 60up country spirit each bottle containing 650 ML which was kept in one big nylon hand bag at the street shop of one Rabin Limbu and lodged a written complaint against one Rabin Limbu s/o Himan Limbu of Chotafapri PS Bhaktinagar Dist Jalpaiguri to the effect that on 14.01.23 at 20.05 hrs received a source information from Bottle company road under Bhaktinagar PS that one person namely Rabin Limbu has gathered huge quantity of liquor in his street shop at Bottle company More for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-660 dated 14.01.23. As per your kind instruction myself along with ASI Dipak Karmakar, C/1431 Dilip Barman, CVF/935 Biplob Roy & CVF/014 Sumit Kumar Roy all of Bhaktinagar PS proceeded to the PO to work out the information. At 20.15 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his street shop which was kept in the shop of Rabin Limbu. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his street shop after prepared proper seizure list and after taking advantage of darkness the alleged person fled away from the spot (The seizure was made in between 20.40 hrs to 21.20 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Rabin Limbu s/o Himan Limbu of Chotafapri PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
