In producing herewith the following seized articles as per proper scizure list viz: (1) 15 (Fifteen) bottles of Himalayan Gold 60up country spirit each bottle containing 650 ML which was kept in one big nylon hand bag at the street shop of one Rabin Limbu and lodged a written complaint against one Rabin Limbu s/o Himan Limbu of Chotafapri PS Bhaktinagar Dist Jalpaiguri to the effect that on 14.01.23 at 20.05 hrs received a source information from Bottle company road under Bhaktinagar PS that one person namely Rabin Limbu has gathered huge quantity of liquor in his street shop at Bottle company More for selling the same in the open market for his wrongful gain without any documents/license. I therefore request you a specific case may kindly be started against the accused person namely Rabin Limbu s/o Himan Limbu of Chotafapri PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
