WB74BD8301 from Champasari to Bidhan Market had a road accident on 13/01/2023 around 9:30 PM at Donbosco More, Sevok Road Siliguri. While they come across Donbosco More, a truck bearing DO WB73F6546 had hit Scotty where a rider Ashok Rajak was severely injured and was admitted to intensive care unit (ICU) at Lifeline hospital, checkpost, pillion rider named Ajay Shah got injury.
