- 2. That the said land is a recorded land and is registered under my name and is not owned by any other person and is neither a Govt. owned land or a vested land. Furthermore, the said land has been officially served by the concerned B.L & LRO on directions of the Chief Judicial Magistrate. The said report of the B.L & LRO has been enclosed for your perusal.
