Dear Sir,

With due respect I Smt. Runa Sharma Dutta, W/o. Sri Rajarshi Dutta, Resident of Gayetri Apartment, Rabindra Nagar Main Road, Opposite of Mitra Sangha Club, Ward No. 37 of S.M.C., P.S Bhaktinagar, Dist. Jalpaiguri, would like to inform you that, yesterday at about 8 p.m. I alongwith my husband and son came to my flat with our four wheeler (Wagon R) being registration no. WB 74 BF 5867 and at that time one E-Rickshaw / TOTO came with full speed and full intoxicated condition and suddenly he hit my car forcefully and for that the right side back door of our car badly damaged and when we can understand said toto driver fled away leaving behind his toto and thereafter my husband somehow parked the said vehicle on the road and trying to enter into the garage but due to brutal damage it was not possible.

I would like to further inform you that, after elapsing of almost one hour some unknown persons came to my place alongwith lathi, rod, punch, hockey stick and started to abusive filthy languages and one of them who introduce himself as his name is **Alok Saha** of Ward no. 38, Dashghar alongwith the said Toto driver and he further told me that he is one of the political influencer and always he used police in his pocket and suddenly one **Bijay Mandal** and **Nilu Das** of the members of Mitra Sangha Club came to my place and they have also started to humiliated me and my son and at that time my husband was not at home. And they started to shouting and threatening me and my son and they used some vulgar languages which cannot utter in a civilized country. Thereafter said Alok Saha having criminal background alongwith said toto driver and his 8 to 10 associates trying to molested me and said Alok Saha pushed me by hitting of my chest and when my husband came to the place and they all have started to beaten my husband and son brutally and for that my husband and son injured, and when my neighbour Sri Prabir Dey and his wife Smt. Sampa Dey alongwith one Sikha Dutta came to save us from the clutch of the said miscreants, they threatened them if they would help us they will firstly kill themselves and thereafter they will kill us and for that no one step forward to help us.

It is pertinent to mention here that, the Mitra Sangha Club is just opposite of my flat and the above mentioned club member Sri Bijay Mandal is always using eve teasing to the local ladies / women and after sunrise on everyday the above named members started to drink alcohol in the premises of club and using slung languages just to harass local public like us.

It is further pertinent to mention here that one Mithun Debraj who is the ward president of ward no. 37 came to my place and requested them to settle the disputes but they did not hear any words and in presence of said Mithun Debraj they have done their illegal activities.

Under the above circumstances I would like to request you to investigate the matter and do needful according to the law and we alongwith the family of Mr. Prabir Dey and Sikha Dutta are also scared for their illegal activities and kindly look into the matter seriously as we can live peacefully.
