

Sir,

In producing herewith 01 (one) arrested accused named Anupam Barman (20 yrs) S/O Prafullya Barman of Banikhari, PO- Nemai, PS- Matigara, Dist.- Darjeeling along with following articles under proper seizure list :-

(i) 07 (Seven) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 MI in each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

(ii) 22 (Twenty two) bottles of 'IMPERIAL BLUE SUPERIOR GRAIN WHISKY' containing 180 MI in each bottle and marked as "Exhibit- "B" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit B-1".

I, SI Goutam Mallik of Matigara P.S. SPC would like to lodge this written complaint against the above noted arrested accused namely Anupam Barman (20 yrs) S/O Prafullya Barman of Baniakhari, PO- Nemai, PS- Matigara, Dist.- Darjeeling to the effect that on 17.01.23 at 18.10 hrs I received a specific source information that one Anupam Barman of Banikhari, PO- Nemai, PS- Matigara, Dist.- Darjeeling is selling illicit liquor at his Shop at situated at Lalpul, Near Barsana Hotel under PS- Matigara, Dist.- Darjeeling. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 817 dated 17.01.23 and informed the fact to the officer-In-Charge, Matigara PS and as per his kind order and direction myself along with C/1053 Paresh Rava, C/374 Debraj Biswas, C/219 Sanatan Chitrakar, C/974 Mintu Sena and CV/155 Sukumar Das all of Matigara PS left for Lalpul near Barsana Hotel under PS- Matigara, Dist.- Darjeeling to work out the information in hand. After arrival at Lalpul near Barsana Hotel and being identified by the source we held raid at the shop of accused Anupam Barman of Banikhari, PO- Nemai, PS- Matigara, Dist.- Darjeeling situated at Lalpul near Barsana Hotel under PS- Matigara, Dist.- Darjeeling and managed to apprehended him. On being asked he disclosed his identity as noted above and also disclosed that he is selling illicit liquor at his shop without any license for his wrongful gain. On further being searched the above noted seized articles were recovered from his residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned detained person named Anupam Barman (20 yrs) S/O Prafullya Barman of Banikhari, PO- Nemai, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 17.01.23 in between 18.55 hrs to 19.35 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against arrested accused namely Anupam Barman (20 yrs) S/O Prafullya Barman of Banikhari, PO- Nemai, PS- Matigara, Dist.- Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


