This is to inform you that I Doctor Vivek Gaurav (DM, Nephrology) S/O of Mr. Dhruv Kumar Saraf was a resident of Flat no 4/A/5 Barsana Apartment, Kharail Road, P.S - Matigara, Siliguni, Dist - Darjeeling. I was on my duty at Mitra Nursing Home attending of emergency call, while this person Sagar Ghosh, son of Amel Ghosh, resident of Anabinda pally near Anabindapally sporting Club had come to me to talk casually to which I denied to explaining him the emergency of that situation.

On denying to talk, he started talking to me roughly and started abusing me, he started hitting me on the running car with his personal ornament (kara) and my head started bleeding to which I hit back.

When we reached Mitra Nursing Home, and again he started abusing me vigorously then I hit back for my self defence. Since I was bleeding the nurses and doctors shifted me to the ICU for immediately.

Therefore, I requesting you to kindly take necessary action since I am afraid as he has threatened to harm my family and my near and dear ones.
